
# ACTION-ROOK ()FA "FATHER-MURDERER"

#### ACTION BOOK OF A "FATHER MURDERER"

This is my (physical) son Marco

This is a 50-year-old man who violated his own father from the family against the will of his sick mother in order to destroy him existentially

This is a chronological 10-year protocol of his ruthless action against a 75-year-old who can no longer be able to work due to his age

These are not nocturnal nightmares, but daily painful experiences

This is also the unimaginable example of the character decay of a son who hides his deep hatred behind played love. Like a sneaky enemy in the camouflaged robe of a familiar friend

This is a list of verifiable facts about the unrestrained acts of a heartless and unscrupulous narcissist, to whom not only the money has risen to his head

This is also a son who distorted his mother's fortune in a short time to finance his roaring millionaire life in Ibiza and his obligations after two failed marriages

But this is also the admission of a desperate father who failed at a young age to teach his children the essential values of human life

# WHO IS THIS BOOK FOR?

When a biological son destroys the almost 50-year marriage of his parents for selfish motives and his biological father disputes the existential right to life, it is far more than a bad family drama.

It is also an alarming signal for everyone who has to do with this person privately or on business.

There is a dispute everywhere. Between business people, friends and often also relatives. But no interpersonal conflict is as heartbreaking and unforgivenable as the painful betrayal and the will to destroy one's own blood.

Anyone who is able to treat his own father in this way is a great danger to the people in his personal environment. I am often asked about the reasons for this deeply hurtful conflict. What for heaven's sake could a son (even a father of three!) To do such deeds? And how does he ever want to justify them to himself?

Excessive drug use could be an explanation for the total loss of self-control and morality here. But would that be an excusable justification?

Marco is probably under the bad influences of "false" friends and the almost incurable addiction to a "life in intoxication". This is also the name of my current (freely invented) novel, which is inspired by the typical world in which Marco lives today.

Confidential family matters do not belong in the public. This is an essential principle. However, this very special case is an exception, because it is also a warning example for all people who have to do with Marco.

Therefore, I limit this book of actions to a selected group from his business and private environment.

The content is based on verifiable facts. Truths are not slander and the description of my experiences is more selftherapy than revenge.

An old proverb says: "God protect me from my friends, I can take care of my enemies myself."

But who protects an "old" father from the cruel realization that his own son is no longer a son?

This is even more painful than all the low blows of recent years.

# **FIRST BREAK WITH THE FATHER**

#### January 2014

Night call from Tokyo (wedding trip with short-term wife Monica). O-Ton from Marco: "I never want to have anything to do with you again; I am no longer your son and you are no longer my father."

Occasion: Dispute of his organizationally overwhelmed wife with the shipping company I recommended for the household move from Tel Aviv to Lucerne.

### **HYPOCRITICAL LAUDATORY SPEECH**

#### 26. January 2014

Loving speech on my 65th Birthday brunch in front of about 50 - sometimes tearful - guests who congratulated me on this great son, who promised his blissful father a trip together every year.

The first trip (South Africa) took place three years later accompanied by a project manager, who developed a largescale property acquired in Ibiza for Marco - according to rumors, partly circumventing the local building law. The threeday flight to Cape Town was in no way the announced private trip of father and son, but a selfish business trip to meetings with architects specializing in luxury villas.

# **NO ACCESS FOR THE FATHER**

#### June 2016

In contrast to personal friends and business partners, his own father was not allowed in the VIP room at the Noah Conference in Berlin.

I had promised my participation at his repeated request and had gone to Berlin.

The meeting with Marco lasted less than ten seconds; he did not even consider it necessary to offer me a glass of water in the great summer heat.

## **COERCION TO DIVORCE**

#### 2017 - 2018

After 45 years of marriage (!) Of his parents, Marco began to urge his mother to divorce for motives that are still not open to me today. He himself was already divorced twice at the age of 42 at that time and disputed in court with both wives, with whom he each has a daughter.

In the meantime, he has married again and has become a father again.

Interesting: Since the separation of the parents (mid-2019), the "caring" son has further reduced the already sparse contact with his mother. My wife has been seriously ill in recent years and has been assigned a professional caregiver for over three years, because neither Marco nor his sister were considered suitable for this responsible task by the care court!

# **NEW GENERAL POWER OF ATTORNEY**

#### 3. December 2018

At the end of 2018, Marco secretly began the implementation of his war against his own father.

Together with his sister and mother, he arranged a notary appointment to cancel the general power of attorney between his parents that has existed since May 2002 and to set up a new version in favor of both children.

The secret notarization took place one day before the FPM shareholders' meeting.

I only learned about this months later through a lawyer's letter asking me to hand over the old general power of attorney to my wife.

## **IMMEDIATE EXPULSION FROM THE "VOTE LEADER"**

#### 4. Dezember 2018

After I took over the management of the family company FPM-Immobilien shortly after the death of her father (2002) at the request of my wife and gave up my self-employment as a successful PR consultant and journalist in 2007 due to the high workload, Marco staged my immediate expulsion on the occasion of a shockingly hostile shareholders' meeting after more than 16 years of dedicated work. The next morning I received an email humiliating in tone and content with abstruse accusations, which he signed with his

name and as a self-appointed managing director on behalf of his mother and sister with "voting leader".

A term that inevitably reminded me of the language use of the Nazis, who had also murdered large parts of his ancestors. People he never asked about and who play no role at all in his consciousness.

Significantly, Marco had ignored any request for discussions about the company's activities and plans in previous years. He has neither the desire nor the time. The sudden interest obviously developed from increasing need for money, because despite high income with his Noah Conference, the funds were no longer sufficient for his astronomical expenses for excessive life alternately in Lucerne and Ibiza. O-Ton of a former business partner who has sued a claim in the millions against him: "He lives as a millionaire like a billionaire."

## **INACTIONAL "VOTE LEADER"**

#### January 2019

After Marco had appointed himself as the new FPM managing director, I was supposed to do the necessary work for him.

He himself didn't feel like it ("my job is not to take care of broken taps").

Since there was no basis for cooperation, he commissioned his then 20-year-old nephew Leon with the day-to-day business and freely granted him power of attorney to the company account.

Under Marco's (neglected) supervision as the responsible managing director, the occasional hourly repeatedly reached into the cash register and secured the favor of the dear uncle; (according to his own expression!) Also as his drug courier between Hamburg, Lucerne and Ibiza.

## 70. BIRTHDAY: INSULTS INSTEAD OF Congratulations

#### 22. Januar 2019

First congratulator on my 70th My son's birthday was. He called early in the morning.

Instead of the expected congratulations, he showered me with minor questions about business processes, for which he himself was now responsible and whose answers resulted from the documents read to him.

I immediately realized that he was only looking for a pretext to spoil (also) this special day for me. At least he didn't have a kind word for his father.

# **FRAUDULENT DECEPTION**

#### September 2019

After Sylvia filed for divorce at the insistence of her son in July 2019, Marco proposed an amicable separation agreement to me if I moved out and looked for another home.

I agreed in principle, as I saw no point in arguing for claims in court after almost 50 years of marriage.

At over 70, I no longer had the slightest chance of gainful employment due to my age to secure my remaining life.

As requested, I worked out a corresponding proposal, which Marco - even after consultation with my lawyer - agreed to and gave the green light for the notarial certification on the 10th. October 2019. A few days before the notary appointment, he withdrew his commitment completely surprisingly and without justification.

In the meantime, I had signed a lease for an apartment in confidence in his commitment and had not dreamed that Marco would trick his own father out of the house with a fraudulent deception.

# **DEATH WISH VIA VIDEO CLIP**

#### 26. April 2021

If you couldn't see it with your own eyes, you wouldn't believe it. I received this hate video via WhatsApp. Was Marco in a drug intoxication on this recording? His facial expression and especially his eyes indicate this.

The sight of my suffering wife is even less bearable than his nasty insults.

# **INVENTED WITNESS REPORT**

#### 10. June 2021

Speaking of threats: I have also received some of them. I suspect that Marco has commissioned his financially dependent nephew Leon (son of my daughter Sharon) to do so.

The fact that he personally participated in the Father's War as the spoiled beneficiary of the wealthy uncle is proven, for example, by the following incident: On the 10th June 2021, my wife Sylvia called me with a request to visit her.
